CONSENT DETERMINATION ARABANA NO 2 PART 1 NATIVE TITLE CLAIM

TO: THE ARABANA NO 2 NATIVE TITLE CLAIM GROUP being those individuals who can establish their descent from at least one of the following Apical Ancestors

- a. **STRANGWAYS - Lily and Rang (*Buguwide*) Strangways**, the parents of siblings, Sarah (*Gadjibuga*), Henry (*Wapili*), Clara (*Midlangla*), Fred (*Murilli*) and Sidney;
- b. **ADAMS - Gina Adams**, the mother of Jessie (who married Sandhill Jack);
- c. **AMOS - Jacob** the apical ancestor of the **Stanley Amos family**. Jacob's daughter, Millie and her husband Stanley Amos;
- d. **STEWART, WARREN, WOODS, DODD AND BUZZACOTT - Barralda Bunda**, an Arabana woman and the mother of **Barralda Coupa (also known as Laura)**;
- e. **CONWAY - Aggie** (who was married to Jim Conway), is the mother of siblings Florrie, Eddie, Clancy and Ida Conway;
- f. **WARRINA, DUCK and GEPP - Johnny Warrina**, the father of siblings, Lexie, Roy, Maudie, Lennie and Alma Warrina;
- g. **ALLEN - The mother** of Tim Allen, who married Frank Allen;
- h. **SAMUELS - Topsy and Allen Samuels**, the parents of Ruby;
- i. **STUART - An Arabana woman** who married Adam Ferguson, and who is the mother of Louise (who married Ted Stuart);

and who claim to hold native title rights and interests on the Arabana No 2 Part 1 native title claim area (see map on following page)

1. BACKGROUND

On 22 April 2012 in Port Augusta, the Arabana native title holders authorised the Arabana No 2 Part 1 claim over this area. The Part 1 claim has now been accepted by the State of South Australia and they are prepared to recognise Arabana native title over the area on the map below on the terms set out in the draft orders.

2. MINUTES OF THE CONSENT DETERMINATION

This meeting is to approve the Orders of the Consent Determination to be made by the Court. Minutes of the Consent Determination in relation to the Arabana No 2 Part 1 will be available at the meeting.

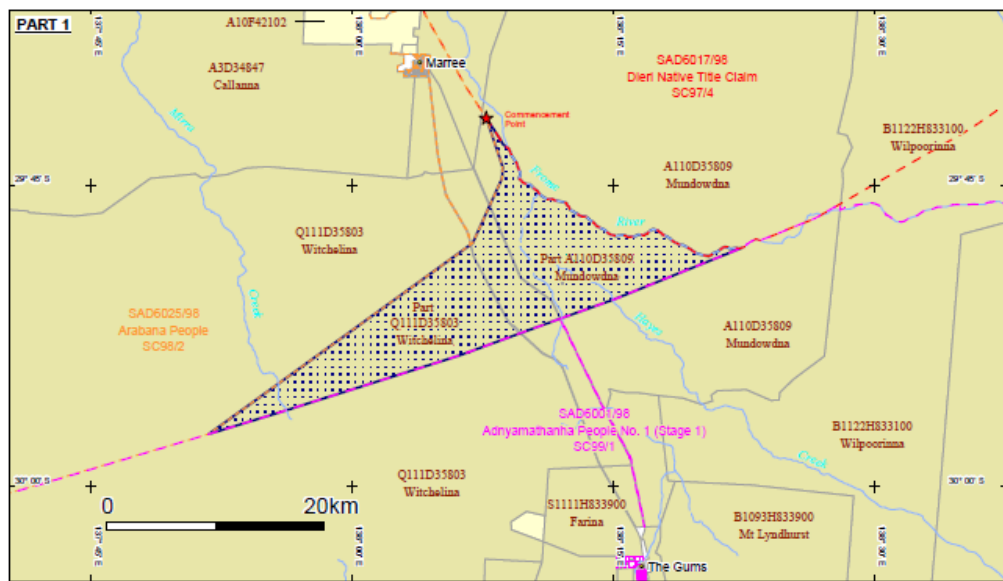
The terms and conditions of the meeting are very similar to the Arabana No 1 claim. The Consent Determination recognises the Arabana People, the same as in the Arabana No 1 claim, and recognises your Native Title rights and interests. These rights and interests include a right to live on the country to hunt, fish, gather and use the resources for non-commercial purposes. It also allows you to make decisions about the determination area.

Those that hold Native Title are all of the descendants of the above-named Apical Ancestors. Native Title does not give you rights over minerals and petroleum and these are excluded, but it does give you a right to negotiate with the mining companies if they are intending to do any work on your land.

At the meeting, you will be asked to resolve that the body that will represent you as agent of the Traditional Owners is The Arabana Aboriginal Corporation RNTBC of which most Arabana People are members. The Arabana Aboriginal Corporation RNTBC has been appointed agent for the Arabana No 1 Traditional Owners.

The Arabana Aboriginal Corporation RNTBC will need to discuss and work with you to confirm your support for any mining agreement that is to be signed on your land. There are no agreements at present over the claim area.

3. CONSENT DETERMINATION

It is likely that the consent determination will be held in Adelaide in mid-2020. The date is to be set by the Judge at a later time.

4. RESOLUTIONS TO BE PUT at the meeting:

- Motion #1: That the Arabana Native Title holders approve the proposed Consent Determination Orders for Native Title in the Arabana No. 2 Part 1 claim area.
- Motion #2: That this meeting of the Arabana Native Title holders authorises the Arabana Aboriginal Corporation RNTBC to become the Prescribed Body Corporate for the Arabana No. 2 Part 1 claim area as agents for the Arabana native title holders.
